Current license holders can visit the Division website to complete the Child Support Certification process each year prior to a license or permit purchase.

Visit [www.njfishandwildlife.com](http://www.njfishandwildlife.com). Click on the box in the top left hand corner "Buy your licenses and permits online" and follow the steps to Complete the NJ Child Support Certification without purchasing a license. Print out the confirmation copy and mail this along with your application, proof of residency and fee.

The certification is good until December 31 of the year it is completed. The process of certification must be repeated each calendar year.

### **NJ Child Support Certification Requirement Information**

Completing the Child Support Certification is required when purchasing a hunting or fishing license or related permit. The certification must be completed annually.

Under the Child Support Program Improvement Act, N.J.S.A. 2A:17-56.7a, et seq. (pdf, 215kb), the NJ Division of Fish and Wildlife (DFW) is required to obtain this information, just as it is required to obtain Social Security Numbers. DFW realizes the imposition this has placed upon our constituents, our license agents and our staff and understands that individuals have concerns regarding the collection of this information. (Individuals with questions regarding the status of their child support obligations should contact their local probation department.)

In order to address these concerns, DFW worked with the Office of the Attorney General, the Administrative Offices of the Court and State Information Technology staff to develop a convenient, efficient and secure way of meeting our obligations under this law. **As a result, those wishing to purchase a license can be certified on-line.**

The Office of the Attorney General highly recommends completion of the Child Support Certification online using the secure Division website, listed below. If that is not possible, please complete the application below and include with your documents when purchasing your Commercial Marine License.
